B19/004	Agenda Item No.4: Deep Dives			
	The Board considered a paper on the approach to undertaking Deep Dive Scrutiny Reviews. Typically each 'Deep Dive' would consist of four meetings, the first to scope the review, the second and third to undertake the Deep Dive and the fourth to formulate conclusions. However, the number of meetings was flexible depending on the nature of the issues under review.			
	A draft revised Board Calendar was circulated at the meeting with indicative dates for the four meetings of each of the first two Deep Dives shown in red. Governors were asked to let the Clerk know of any difficulties with the proposed dates.			
	It was noted that the Terms of Reference (including who would be involved) for the first Deep Dive on Construction and Engineering (CSTEM) had been approved by the Board at its meeting on 18 December 2018 and that the first meeting was to take place on 22 January 2019.			
	The Chair outlined his expectations that the conclusions of Deep Dives should be reported jointly by Governors supported by relevant SLT members at the next meeting of the Board following the conclusion of the review.			
	It was noted that each Deep Dive would be different and that the nature of the meetings (especially the second meeting) would differ and be agreed by the group at the conclusion of Meeting 1.			
	The second Deep Dive would be on English and Maths and was due to start at the beginning of April. Any learning from the first Deep Dive would be incorporated into the approach for future Deep Dives.			
	It was RESOLVED: to approve the approach to Deep Dives.
